2 ~ A Matter of Public Record

1 Corinthians 15.1-11 — Reminded of the Gospel

- "First importance" literally, "among the first things."
- "Received" & "delivered," language of passed-on tradition (vv. 1, 3); preached by apostles (vv. 9, <u>11</u>-15).
- "That" functions like an English colon used to set off the items in a list.
 - How many times does "that" appear in verses 3-5?
 - What are the events designated by "that"?
 - In terms of space devoted to them, which of the "thats" is given more attention?
- Why were the appearances so important in early church preaching?

Examples for Additional Study

Acts 2.22-36 — Peter's sermon to a Jewish audience (Pentecost)

- "this Jesus, delivered up according to the definite plan and foreknowledge of God, you crucified and killed by the hands of lawless men" (v. 23).
- "God raised him up, loosing the pangs of death, . . ." (v. 24; note: vv. 24-35, twelve of the fifteen verses in the sermon, are about the resurrection).
- "... the patriarch David was buried, and his tomb is with us to this day.... the Christ was not abandoned to Hades, nor did his flesh see corruption" (vv. 29, 31).
- "This Jesus God raised up, and of that we all are witnesses" (v. 32).

Acts 10.34-43 — Peter's sermon to Cornelius

- "They put him to death by hanging him on a tree, ..." (v. 39).
- "... but God raised him on the third day ..." (v. 40)
- "... and made him to appear, not to all the people but to us who had been chosen by God as witnesses, who ate and drank with him after he rose from the dead" (vv. 40-41).

<u>Acts 13.16-43</u> — Paul's sermon in the Jewish synagogue in Pisidian Antioch (parallels Peter's sermon in Acts 2

- "And though they found in him no guilt worthy of death, they asked Pilate to have him executed" (v. 28).
- "And when they had carried out all that was written of him, they took him down from the tree and laid him in a tomb" (v. 29).
- "But God raised him from the dead, ..." (v. 30).
- "... and for many days he appeared to those who had come up with him from Galilee to Jerusalem, who are now his witnesses to the people" (v. 31).

Preaching to Persuade

"² And Paul went in [to the synagogue in Thessalonica], as was his custom, and on three Sabbath days he *reasoned* with them from the Scriptures, ³ *explaining* and *proving* that it was necessary for the Christ to suffer and to rise from the dead, and saying, 'This Jesus, whom I proclaim to you, is the Christ.' ⁴ And some of them were *persuaded* and joined Paul and Silas, as did a great many of the devout Greeks and not a few of the leading women."

¹⁶ "Now while Paul was waiting for them at Athens, his spirit was provoked within him as he saw that the

city was full of idols. ¹⁷ So he *reasoned* in the synagogue with the Jews and the devout persons, and in the marketplace every day with those who happened to be there. ¹⁸ Some of the Epicurean and Stoic philosophers also conversed with him. And some said, 'What does this babbler wish to say?' Others said, 'He seems to be a preacher of foreign *divinities*'—because he was preaching Jesus and the resurrection'' (Acts 17.2-4, 16-18).
